above sanction is subject to fulfillment of following conditions:-

The grant for recognition is not extendable and does not in any way imply any obligation to recognize/affiliate beyond Class VIII.

The School shall abide by the provisions of Right of Children to Free and Compulsory Education Act, 2009 (Annexure I) and the Right of Children to Free and Compulsory Education Rules, 2009 (Annexure II).

The School shall admit in class I, to the extent of 25% of the strength of that class, children belonging to weaker section and disadvantaged group in the reighborhood and provide free and compulsory elementary education till its completion. Provided, further that in case of pre primary classes also, this norm shall be followed.

For the children referred to in paragraph 3, the School shall be reimbursed as per Section 12(2) of the Act. To receive such reimbursements school shall provide a separate bank account.

The Society/School shall not collect any capitation fee and subject the child or his or her parents or guardians to any screening procedure.

The School shall not deny admission
